



TOWN OF LAKESHORE

REQUEST FOR TENDERS FOR NOTRE DAME STREET AND WEST RIVER STREET INTERSECTION IMPROVEMENTS (ROUNDBOUT)

The work is located in the Community of Belle River in the Town of Lakeshore at the Notre Dame Street and West River Street/West Belle River Road Intersection with some work on West River Street north of the intersection and on the bridge over the Belle River, east of the intersection.

The work generally consists of the supplying of all materials, labour and equipment for the removal of existing pavement and sidewalks, storm sewers and catch basins and the construction of storm sewers, catch basins, maintenance holes, relocation of maintenance holes and valve boxes, joint use utility trench ducts and vaults, concrete and asphalt pavement, curb and gutter, driveway approaches, concrete sidewalks, retaining walls, decorative street lighting, bridge rehabilitation, landscaping, traffic control and coordination with various utility companies as specified in the Contract Documents.

Beginning **Thursday, May 31, 2018, 12:00 p.m. local time**, complete Tender Documents may be obtained from the Town of Lakeshore during regular business hours upon payment of a non-refundable deposit of \$100.00 (\$88.50 + \$11.50HST). Town of Lakeshore offices are located at 419 Notre Dame Street, Belle River, Ontario, N0R 1A0, during regular business hours. Plans will also be available for viewing at the Windsor Construction Association offices.

Sealed Tenders, clearly marked as to contents will be received by the Purchasing Coordinator, Town of Lakeshore, 419 Notre Dame Street, Belle River, Ontario, N0R 1A0 until 12:00 PM (noon), local time on **Thursday, June 14, 2018**.

On the same day, commencing at 12:05 p.m., local time, the Tenders will be opened and read publicly at the above address.

The Tender must be accompanied by a tender deposit in the form of a certified cheque or bid bond in the amount of 10% of the tender price made payable to the Town of Lakeshore.

The Town will reject any bids not received from Registered Bidders. The bid will be returned unopened. Registered Bidders are those Bidders who have obtained their specifications from the Town of Lakeshore and completed all necessary steps to be included on the Bidders' List, including the provision of identifying information as required, and the payment of any required fees. The Town of Lakeshore shall have the sole authority and discretion to determine whether a Bidder is a Registered Bidder.

The Owner reserves the right to accept any Tender or to reject any or all Tenders.
